Whereas, Health & Medical Education Department, vide letter No. Me-Gztd/270/2022 dated: 01.11.2022, referred two (02) posts of Assistant Professor/Antenatal Care Incharge (Ancillary Staff) one each In GMC Handwara & Udhampur under Open Category, to the J&K Public Service Commission, for selection of suitable candidates; **and,**

Whereas, the posts were advertised vide Notification No. 30-PSC (DR-P) of 2022 dated 30.12.2022. The cut-off date for determination of eligibility was fixed as 31.01.2023; **and,**

Whereas, again the Health & Medical Education Department, vide letter No, Me-Gztd/246/2022 dated: 05.12.2022, referred one (01) post of Antenatal Medical Officer cum Lecturer In GMC Doda, under Open Category, to the J&K Public Service Commission, for selection of suitable candidate; **and,**

Whereas, the post was advertised vide Notification No. 31-PSC (DR-P) of 2022 dated 30.12.2022. The cut-off date for determination of eligibility was fixed as 31.01.2023; **and,**

Whereas, written test was conducted on 07.10.2025. The result of the written test was declared vide Notification No. PSC/Exam/S/2025/53 dated 12.11.2025, In pursuance of Rule 42 of J&K Public Service Commission (Conduct of Examination) Rules, 2022 and Rule 31 of J&K Public Service Commission (Business & Procedure) Rules, 2021, as amended upto date; **and,**

Whereas, the candidates were called for Interview as per the breakup given below:

Whereas, the viva-voce of candidates was conducted on 11.02.2026, with the assistance of Experts from outside UT. Out of 13 candidates 04 candidates remained absent; *and,*


Whereas, on the basis of the performance in the written test, Interview, and other related attributes in pursuance of Rule 44 (ii) of the J&K Public Service Commission (Business & Procedure) Rules, 2021, the merit of the candidates who appeared in the Interview, a provisional Select List was issued vide Notification No. 23-PSC (DR-S) of 2026 Dated: 08.04.2026, for the post of Assistant Professor/Antenatal Care Incharge (Ancillary Staff) in GMC Handwara & Udhampur and Antenatal Medical Officer cum Lecturer in GMC Doda, in Health & Medical Education Department, with the advice to the candidates to furnish their objections, if any, to the Commission within five days from the date of issuance of ibid Notification.

Whereas, in response to the ibid Notification, Dr. Gitanjali Kapoor vider her representation dated 17.04.2026 has submitted that during verification of documents she had submitted 04 presentations, however the marks for the presentations do not appear in the Notification dated 08.04.2026 for the post of Assistant Professor/Antenatal Care Incharge (Ancillary Staff) in GMC Udhampur & GMC Handwara and Antenatal Medical Officer cum Lecturer in GMC Doda; *and,*

Whereas, the presentations submitted by the applicant at the time of interview have not been accepted by the Experts and the assessment/award

of the special attributes is the domain of subject experts and their decision is accepted as final by the Commission.

Now, therefore, the representation dated: 17.04.2026 submitted by the applicant has been examined and found devoid of merit, and is hereby rejected.
