The tenderers shall give the list of standard accessories with their specifications to be supplied alongwith the items.

The items shall be delivered by the successful tenderer at the office premises of the Commission in Srinagar. The tenders must be accompanied by an earnest money of Rs.50,000/- for Desktp & Laptops; Rs.4,000/- for Printers; Rs.50,000/- for Workcentres; Rs.4,000/- for Fax Machines; Rs.6,000/- for Photocopiers & Rs.20,000/- for OMR Scanner in the shape of FDR/CDR pledged to the Secretary, J&K Public Service Commission. The tenders not accompanied by the earnest money shall not be accepted.

The earnest money shall be refunded to the unsuccessful tenderers. In the case of successful tenderers it shall be treated as part of security. Cheques/Demand Drafts etc. shall not be accepted.



There shall be a warranty period of not less than one year from the date of installation of machines. In case of any malfunctioning requiring repair/replacement, the supplier shall have to repair/replace the whole system or the part thereof depending on the nature of fault, at his own cost.

The successful tenderers shall have to supply the ordered items within seven days from the date of placement of supply order. 95% payment shall be released after supply/installation and confirmation by Receipt Committee about importing of supplies with the specifications prescribed and as vetted by the State I.T. Department. The balance of 5% shall be made after the expiry of the warranty period of one year.

The supplier shall impart demonstration and training to our operators for operating the machines free of cost and charges.

As soon as the acceptance of the tender is communicated to the successful tenderers, the contract shall be complete and binding on him and also execute an agreement with the department.

Failure or default of the tenderer to supply the material in accordance with the specifications or within the stipulated time, or failure to fulfill any of the terms and conditions mentioned herein or in the agreement to be executed by the parties shall render the tenderer liable to such penalty as may be provided in agreement, besides the forfeited of the security deposit.

The Commission reserves the right to accept or reject any tender without assigning any reason thereof.

In case of any dispute arising in respect of any of the terms and conditions of the tender, the decision of the Secretary, J&K Public Service Commission, shall be final.
